Services Offered:

- CRN Evaluation \$70
 - o CRN Evaluation fee must be paid at least one (1) day before your appointment.
- Drug and Alcohol Assessment (DDAP) Provided by Carbon Monroe Pike Drug and Alcohol Commission. Inc ---\$100
 - DDAP Assessment fee must be paid at least one (1) day before your appointment.
- Alcohol Highway Safety School (AHSS) \$300
 - You must call 570-517-3926 to schedule.

Drug and Alcohol Assessment (DDAP):

A drug and alcohol assessment may be REQUIRED IF:

- a. BAC was .16 or greater
- b. Refused the chemical testing
- c. Drug related DUI (including Marijuana)
- d. Under 21 years old at time of offense
- e. Prior DUI
- f. If CRN results recommend an assessment
